

**RESOLUTION OF THE AURORA ELECTION COMMISSION APPOINTING  
FREEDOM OF INFORMATION OFFICERS AND DESIGNATING EMPLOYEES TO  
RECEIVE OPEN MEETINGS ACT**

Resolution No. 2011-6

**RECITALS**

WHEREAS, the Aurora Election Commission (“Commission”) is a body politic and corporate, organized and existing pursuant to the Election Code, 10 ILCS 5/1-1, *et seq.*; and

WHEREAS, the Commission is a “public body” pursuant to Section 1.02 of the Open Meetings Act (“OMA”), 5 ILCS 120/1.02, and Section 2 (a) of the Freedom of Information Act (“FOIA”), 5 ILCS 140/2 (a), and, accordingly, subject to the provisions of those Acts; and

WHEREAS, effective January 1, 2010, Section 5 of Public Act 96-0542 amended the OMA to require that a public body designate employees, officers or members of the body to receive training on compliance with the OMA and Section 10 of Public Act 96-0542 amended the FOIA to require that a public body designate one or more officials or employees to act as the body’s Freedom of Information Officer; and

WHEREAS, Commission employees, Executive Director, Linda Fechner and Assistant Executive Director, Deb Flores, have duties requiring their regular attendance at or assisting with Board of Election Commissioner meetings and, therefore, should be the Commission employees designated to receive OMA training; and

WHEREAS, Commission employees, Linda Fechner and Deb Flores have heretofore administered FOIA requests and, therefore, it is appropriate that they should continue to do so and, accordingly, be designated Freedom of Information Officers for the Commission; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE AURORA ELECTION COMMISSION, AURORA, ILLINOIS, in regular session assembled, as follows:**

**SECTION 1.** The recitals set above are incorporated herein and made a part hereof.


**SECTION 2.** Commission employees Linda Fechner and Deb Flores are hereby designated the Commission employees to receive OMA training, and Commission employees Linda Fechner and Deb Flores are hereby designated and appointed Freedom of Information Officers for the Commission, effective immediately, to exercise all powers and to carry out all duties of that office as now provided for or as may be hereafter provided for.


**SECTION 3.** This Resolution shall take effect May 25, 2011.


