

**A RESOLUTION APPROVING AN AGREEMENT  
FOR PREPRINTED VOTER APPLICATIONS WITH  
ILLINOIS OFFICE SUPPLY FOR THE NOVEMBER 6, 2012  
GENERAL ELECTION**

**RECITALS**

WHEREAS, the Aurora Election Commission (“ELECTION COMMISSION”) is a body politic and corporate, organized and existing pursuant to the Election Code, 10 ILCS 5/1-1, *et seq.*; and

WHEREAS, the ELECTION COMMISSION is authorized and empowered, pursuant to the Illinois Election Code, 10 ILCS 5/1-1, *et seq.*, to pass resolutions for the purpose of carrying out its statutorily enumerated duties and responsibilities and those powers reasonably inferred therefrom; and

WHEREAS, the ELECTION COMMISSION is authorized and empowered, pursuant to the Illinois Election Code, 10 ILCS 5/1-1, *et seq.*, to enter into contracts for the purpose of carrying out its statutorily enumerated duties and responsibilities and those powers reasonably inferred therefrom; and

WHEREAS, the ELECTION COMMISSION desires to enter into an agreement to purchase necessary pre-printed poll books, voter applications and ballots for the November 6, 2012, General Election; and

WHEREAS, the ELECTION COMMISSION has received price quotes for said materials from Elect Printing, Inc., doing business as Illinois Office Supply (hereinafter “IOS”) that is reasonable and acceptable to the ELECTION COMMISSION and the ELECTION COMMISSION desires to enter in to an agreement with the IOS that conforms to said quote; and

WHEREAS, the ELECTION COMMISSION finds and that said price quote for the pre-printed poll books, voter applications and ballots for the November 6, 2012, General Election is in the best interest of the ELECTION COMMISSION and the citizens of the City of Aurora.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Election Commission, as follows:

1. That the recitals set forth above are incorporated herein and made a part hereof.

2. That the Board of Commissioners hereby approves an Agreement with IOS for four thousand two hundred seventy-five and 00/100 dollars (\$4,275.00), which is predicated on the Price Quote provided by IOS that is attached hereto and incorporated herein by reference as Exhibit "A".

3. That all resolutions, or parts thereof, in conflict with the provisions of this Resolution are, to the extent of such conflict, hereby repealed.

4. That this Resolution shall be in full force and effect from and after its passage, approval and publication, in the manner provided for by law.

5. That the Executive Director is hereby directed to transmit a certified copy of this Resolution to the Attorney for the Election Commission at 400 S. Knoll, Unit C, Wheaton, Illinois 60187.

6. The Executive Director is hereby directed to transmit a certified copy of this Resolution to the Office of the Chief Judge of the Sixteenth Judicial Circuit, 37W777 Route 38, St. Charles, Illinois 60175.


